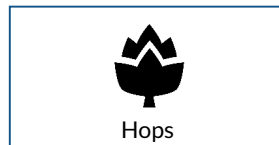
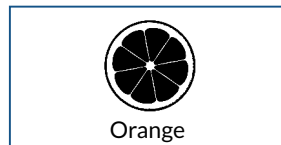

Qualifier Notation	Qualifier Description
