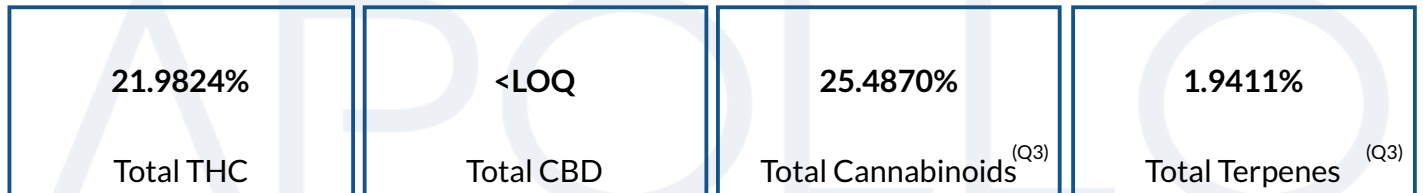

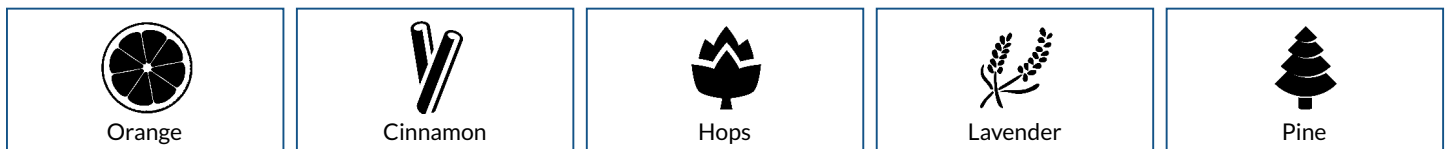

Qualifier Notation	Qualifier Description
