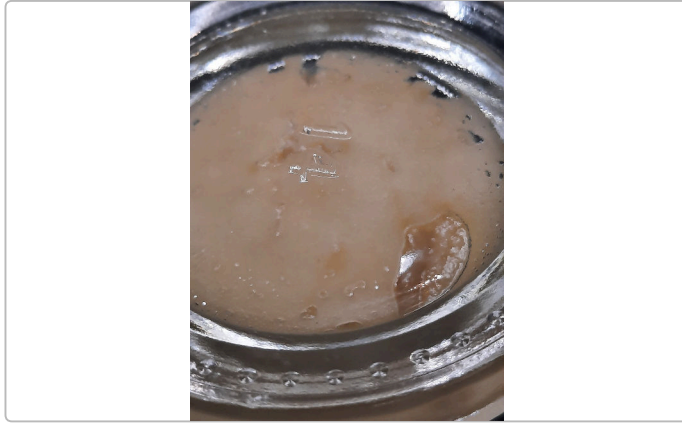

Qualifier Notation	Qualifier Description
